## 2025 Balance of State Continuum of Care Funding Appeals Process

- Applicants will receive a summary of the priority ranking on December 30<sup>th</sup>, 2025.
- Applicants that wish to appeal the ranking committee's decision must notify the
  Department of Housing and Community Development's Homeless and Special Needs
  Program Manager (Darl Wilburn, <a href="mailto:darl.wilburn@dhcd.virginia.gov">darl.wilburn@dhcd.virginia.gov</a>) in writing via email no
  later than close of business January 2<sup>nd</sup>, 2026 with the following information
  - Agency name and contact information
  - Project name
  - Specific reason for appeal
- Applicant should note a clear explanation of the grievance with the grant application or decision-making process in their appeal.
- The Ranking Committee will review all appeals and make final decisions on January 5<sup>th</sup>, 2026 via email vote.
- Applicants will be notified in writing of the appeal outcome not later than January 5<sup>th</sup>,
   2026
