- Housing and Urban Development (HUD) requirement
- Every 5 years DHCD asks "What needs are present in Virginia?"
 - Affordable Housing
 - Homelessness
 - O Non-Homeless Special Needs Housing
 - Non-Housing Community Development
- Every year DHCD submits an Annual Action Plan



Who completes the Consolidated Plan and Annual Action Plan?

- Completed by the state or localities that receive funds directly from HUD
- DHCD completes the Virginia plan for these federal resources





What's included?

- A needs assessment, a strategic plan, and annual goals
- Focuses on housing, homelessness, and community development
- Includes public input and feedback from service providers, housing developers, other state agencies, localities and continua of care



DHCD is currently seeking input on:

- 2023 2028 Consolidated Plan
- First Annual Action Plan
 - July 1, 2023 June 30, 2024

Covering the funds DHCD spends from:

- Emergency Solutions Grant (ESG)
- Housing Opportunities for Persons with AIDS (HOPWA)
- HOME Investment Partnerships (HOME)
- National Housing Trust Fund (NHTF)
- Community Development Block Grant (CDBG)






Needs Assessment Methodology:

- HUD asks DHCD to examine data from American Community Survey (ACS), the Comprehensive Housing Affordability Strategy (CHAS), and other sources
- DHCD uses the data to understand the nature and extent of homeless needs in Virginia
- These findings enable DHCD to inform HUD of the <u>needs</u> that the federal funding will be used to address

6,529

individuals are experiencing homelessness in Virginia


50%

of all individuals experiencing homelessness are Black or African American

DHCD estimates that the numbers of households actually in need of housing assistance is far greater than the number served.




individuals experiencing homelessness








families experiencing homelessness








individuals experiencing unsheltered homelessness

Fundamental Priorities

- Reduce number of individuals experiencing homelessness
- · Reduce length of homeless episodes
- Reduce number of individuals returning to homelessness
- Reduce unsheltered homelessness
- Increase housing stability for at-risk individuals and families
- Support populations in need of specialized services
 - Individuals with severe mental illness, substance use disorders and those who are experiencing chronic homelessness







Emergency Solutions Grant (ESG)

- Administered through Virginia Homeless Solution Program (VHSP)
- Community-based (CoC/Local Planning Group)
 combined application process
- Two-year funding cycle
- ESG eligible activities:
 - o Rapid Re-Housing
 - Shelter Operations
 - Prevention
 - Outreach
 - Rehab/New Construction

- Allocated through the Community-Based Process
- Two-year funding cycle

 - Tenant-based rent assistance
 - Support services
 - Resource Identification
 - Development and Rehabilitation
 - Facility based operations
